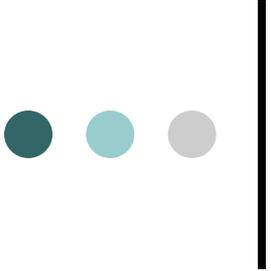

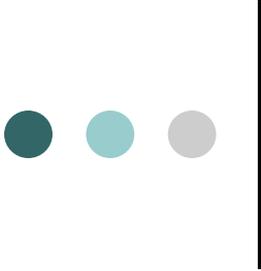

# Overview

- WCL offers about 40 different medium and long term opportunities to study abroad
- WCL provides these opportunities in 23 countries on 6 continents in dozens of areas of study
- Opportunities are available for a semester, year, or two years

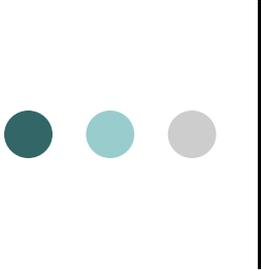

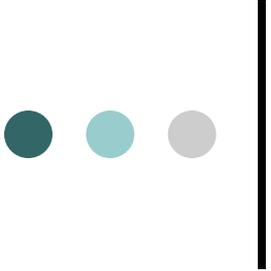

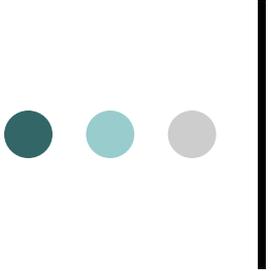
# Semester Exchange: Program Benefits

- Meet like-minded students and faculty





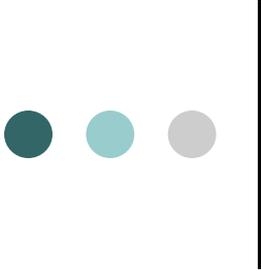
# Semester Exchange: Tuition and Financial Aid

- Your cost of attendance is the same as if you were studying at WCL
  - We waive fees for the student fitness center and U\*Pass as you will not use them while abroad
  - If needed, we will adjust the cost of living to reflect the location where you are studying
- If you are receiving financial aid, you will receive the same aid package (scholarships, grants, and loans). You will not receive federal work-study awards while you're abroad.
- Need help subletting your apartment? Our incoming LLM exchange students need a place!



# Semester Exchange: Due Dates & Qualifications

- Application Deadline
  - Spring Abroad: September 1
  - Fall Abroad: March 1
- Qualifications
  - 2L or above in good standing
  - Minimum 3.0 GPA
  - Previous experience abroad recommended


# International Dual Degree Program Benefits

- Increase job prospects





# International Dual Degree: Tuition and Financial Aid

- In year 3, you pay your regular WCL tuition and fees
  - We waive fees for the student fitness center and U\*Pass as you will not use them while abroad
  - If needed, we will adjust the cost of living to reflect the location where you are studying
  - If you are receiving financial aid, you will receive the same aid package (scholarships, grants, and loans). You will not receive federal work-study awards while you're abroad.
- If your program requires a third or fourth semester abroad, WCL waives the tuition but you still pay student activity and technology fees
  - The programs are structured to allow students to receive federal financial aid (loans) to cover living expenses in the fourth year



# International Dual Degree: Due Dates & Qualifications

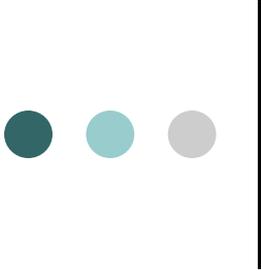
- Application Deadline

- January 31, 2018

- This deadline applies to 1Ls who would go abroad Fall 2019 AND to 2Ls who would go abroad Fall 2018


- Qualifications

- Minimum 3.0/3.3 GPA and in good standing
- Minimum 59/62 credits completed before departure
- All additional JD requirements completed before departure
  - Experiential Learning
  - Upper Level Writing Requirement
  - Pro Bono (recommended)





- Selected candidates invited for committee interview (late February/early March)




# Qualities of Successful Dual Degree Students

- ⦿ “hard-working and truly interested in integrating into another country’s legal system.”
- ⦿ “comfortable that they will likely not follow a traditional career path.”
- ⦿ “adventurous spirit, who is independent but social enough to make friends easily, someone who is flexible and can adjust to things not working the same way in other law schools as they do at American.”
- ⦿ “proactive and strategic about planning their legal careers.”
- ⦿ “have traveled and lived outside of the United States before.”


